RESOLVED, whereas at a meeting held on January 12, 2023, a proposed Local Law was introduced. A Local Law to adopt a real property tax exemption for persons with disabilities who have a limited income in accordance with New York State Real Property Tax Law §459-c. After holding a public hearing on February 9, 2023, as required by Town Law, and having complied with the requirement of notice and publication to consider such Local Law, the Town Board of the Town of Caledonia did adopt such Local Law as Local Law No. 2 for 2023.

ADOPTING LOCAL LAW NO. 3 FOR 2023 – PROVIDING PARTIAL EXEMPTIONS FROM REAL PROPERTY TAXES TO CERTAIN ELIGIBLE SERNIOR CITIZENS

After holding a public hearing on February 9, 2023, as required by Town Law, and having complied with the requirement of notice and publication to consider such Local Law, the Town Board of the Town of Caledonia did adopt such Local Law as Local Law No. 3 for 2023.

The sum of \$250,533.54 may be expended for general repairs upon 44.86 miles of Town Highways, including sluices, culverts and bridges having a span of less than five feet and boardwalks or the renewals thereof.


