SOLAR MORATORIUM

WHEREAS, Notice of a Public Hearing on proposed Local Law No. 2 of 2024, which would enact a Moratorium on Major/Medium Solar Energy Systems, was published in the Livingston County News on December 15, 2023, and the Town Clerk also caused a copy of that Notice to be posted on the sign board of the Town maintained pursuant to Town Law §30(6) on December 15, 2023 and on the Town of Caledonia website (along with the proposed text of the law) on December 15, 2023; and

WHEREAS, the Local Law has been on the desks of all Town Board members since December 14, 2023; and

WHEREAS, adoption of proposed Local Law No. 2 of 2024 is a Type II action under the State Environmental Quality Review Act, pursuant to 6 N.Y.C.R.R. §617.5(c)(36), because it is the adoption of a moratorium on land development and construction; and

WHEREAS, the Local Law was referred to the Livingston County Planning Board, which recommended its approval on February 8, 2024 with a recommendation to align the term "Solar Farm" to the terminology used in the current solar law of "Major/Medium Solar Energy System"; and

WHEREAS, the Town's attorneys have reviewed and approved the proposed Local Law; and

WHEREAS, a public hearing was duly held on that proposed Local Law on January 11, 2024 at 7:15 PM before the Town Board at the Caledonia Town Hall, and all persons desiring to speak were heard;

NOW, on Motion duly made and seconded, it is

RESOLVED that, pursuant to the Municipal Home Rule Law, proposed Local Law No. 2 of 2024, is hereby enacted, and shall be filed with the Secretary of State.
