OPEN FORUM

MIKE BERLIN – ORIDEN ENERGY (HATCHERY SOLAR)

Mr. Berlin representing Hatchery Solar presented drawings and other information to the Board regarding the Hatchery Solar project. Hatchery Solar is a 103-acre solar project to be located on Maxwell Station Rd. Mr. Berlin stated he anticipates completion by 2026. Attorney Kanyuck stated that the Planning Board did SEQR and approved the site plan with conditions. Mr. Berlin stated they are complying with all local input from the Planning Board and met with the Livingston County Planning Department where they saw no issues with the proposed plan. Mr. Berlin is seeking approval from the Town Board to move forward by accepting the Planning Board's decision.

- Letter from Excellus BCBS regarding the company filing a request with the New York State Department of Financial Services to approve a change to group premium rates of up to 25.24%. DFS is required by law to review the requested rate change. DFS may approve, modify or disapprove the requested change.
- Email from National Grid regarding filing with New York State Public Service Commission to establish new electric and gas delivery prices for 2025. The increase would be around 15% if approved by the NYS PSC.
- Email from Genesee Valley Conservancy stating the Doolittle Farm project has been awarded the Grant for Farmland Protection.
- Email from NYS Department of Agriculture and Markets regarding the Doolittle Farm project that was awarded a grant in the amount of \$1,487,195.

Highway Superintendent Ron Beach received a quote for the new sign at Beach Park and asked the Board for approval to purchase the new sign.

Highway Superintendent Ron Beach updated the Board on the following projects that the Highway Crew has been working on:

- > The Turbo Actuator came in.
- > Truck #3 has been repaired.
- ➤ Signed paperwork for the new truck and accessories. The new truck will have a 7-year warranty on the clutch, a Detroit Automatic Transmission and is expected to be delivered by the end of 2024 with payment being made in the 2025 Fiscal Year.

- Soccer is looking to begin using Beach Park.
- Feeley, Cameron, Ellicott roads have been stone & oiled.
- No parking signs have been added to Iroquois Rd.
- Looking to fix a pipe issue on Lacey Rd.
- Paperwork for CHIPS has begun. Ron is waiting for canceled checks paid at this meeting to submit reimbursement package.
- Chris Buckley has reached out to Ron regarding new sidewalks at the Caledonia Mumford Central School.
- > Over the next few weeks, the crew will be doing road work with surrounding towns.
- We received 6 applications for the MEO position. Interviews were conducted and Ron chose 2 MEO's. One full-time and one part/full time.

The Board agreed to the hiring of the 2 new MEO's.

NYS DECAL CHANGES – SETH GRAHAM

Town Clerk Seth Graham updated the Board that within the next month New York State DECALS (Hunting/Fishing Licenses) will no longer be sold on the colored-vinyl paper and will be switching to plain white 8.5x11 copy paper. The Town is responsible for using our own paper and printers/toner to issue licenses foregoing. There has been discussion of adding a \$1 surcharge to the license purchase for the municipality to offset the cost. The printer must be returned to New York State when the change is implemented.
