OPEN FORUM

JIM DUTTON & MICHAEL LUBITOW - CALEDONIA FIRE DEPARTMENT

Jim Dutton & Michael Lubitow from the Caledonia Fire Department presented to the Board a plan to begin as an EMS First Response Unit. They are in the process of applying for their EMS agency number. Their primary goal is to fill the gap in the time it takes for our current EMS agency to respond to emergency calls. They would not be the primary transportation agency but would arrive on scene of emergencies in the district, often before the ambulance.

OPEN PUBLIC HEARING FOR 2022 BUDGET - 7:15 P.M.

Supervisor Pangrazio declared the Public Hearing open at 7:15 P.M. Town Clerk Seth Graham read the Notice of Hearing for the record that was published in the Livingston County News. - Mike Churchill, a full-time motor equipment operator for the Town of Caledonia submitted his resignation letter with plans for retirement.

DEPARTMENTS & COMMITTEES

DISCUSSION – LOCAL LAW OPTING OUT OF ADULT USE CANNABIS RETAIL DISPENSERIES

Supervisor Pangrazio discussed with the Board the options the Town has to opt-in or opt-out of allowing cannabis dispensaries. Supervisor Pangrazio said that the Village has decided to opt-in and allow for retail cannabis dispensaries within the Village. The Board agreed that the Town would also opt-in, allowing for adult use cannabis retail dispensaries.

Attorney Dwight Kanyuck updated the Board that Invenergy has submitted a formal notice to transfer from the Article-10 process to the 94-c process and that their application for Horseshoe Solar has been deemed complete.
