The Town Board's referral letter specified the following:

-5 parking spots maximum

- -one space for owner
- -one space for customer
- -3 spaces for retail cars for sale
- -The 2 parking spots closest to Route 5 are not to have cars parked in them due to visibility concerns.

This business is by appointment only via https://www.momocarsusa.com/ Office will be in shared building space of Peace Love Paws Grooming. Separate entrances.

Cost of inventory is \$5,000 – \$10,000 (no trucks or motorcycles)

Mr. Naveed picks up all cars himself – there will not be a flatbed delivering vehicles

In regard to signage, Mr. Naveed would like a sign on the building. The Planning Board explained should he want something larger or off the building, he would need to come back to obtain approval. May need ADA accessible parking – work with Code Enforcement Officer.

A site plan was not provided. A sample was shown to Mr. Naveed and execrations of what is r4euired were given in detail: parking, signage, lighting, and hours of operation.

Should Mr. Naveed plan to attend the May 27th meeting he will be in contact with the Planning Board Clerk to be placed on the agenda and ensure an electronic version is emailed and 10 copies of all materials are dropped off to the Planning Board clerk by 5/19.
